



ACCENT INNS ROAD TRIP GIVEAWAY

OFFICIAL CONTEST RULES

1. SPONSOR

2. CONTEST PERIOD

The Contest begins on June 24, 2026, at 12:01 a.m. Pacific Time ("PT") and ends on August 9, 2026, at 11:59 p.m. PT (the "Contest Period").

3. ELIGIBILITY

The Contest is open to legal residents of Canada, excluding residents of the Province of Quebec, who have reached the age of majority in their province or territory of residence at the time of entry.

The following individuals are not eligible to enter:

- Employees, officers, directors, agents, and representatives of Accent Inns Inc.
- Any organizations involved in the administration of the Contest
- Immediate family members (parent, sibling, child, spouse, or partner) of the above individuals
- Persons residing in the same household as any of the above individuals

The Contest is void in Quebec and where prohibited by law.

4. HOW TO ENTER

There are two (2) methods of entry.

A. Eligible Stay Entry

Guests/entrants will automatically receive one (1) entry for each eligible stay completed at any Accent Inns location during the Contest Period.

- One (1) entry will be awarded per completed stay and unique confirmation number.
- The individual named on the reservation must be the individual receiving the Contest entry and must meet all qualifications.

The following reservations are not eligible:

B. No Purchase Necessary Entry

Booking + Stay Details

- Hotel nights do not need to be used consecutively.

- Is found to be ineligible; or
- Does not comply with these Official Rules;

the entrant may be disqualified and an alternate entrant may be selected.

9. SKILL-TESTING QUESTION

Before being declared the winner, the selected entrant must correctly answer, without assistance of any kind, a time-limited mathematical skill-testing question administered by the Sponsor.

10. PRIZE DISTRIBUTION

Following successful verification of eligibility and completion of all required documentation:
